If the Shares are registered in the name of more than one holder (for example, joint ownership, trustees, executors, etc.) then all of the registered owners must sign this form of proxy in the space provided on the reverse. If you are voting on behalf of a corporation or another individual, you may be required to provide documentation evidencing your power to sign this form of proxy with signing capacity stated.
3. This form of proxy should be signed in the exact manner as the name appears on the form of proxy.
4. If this form of proxy is not dated, it will be deemed to bear the date on which it is mailed by management of Tervita to the holder.
5. The Shares represented by this form of proxy will be voted as directed by the holder; however, if such a direction is not made in respect of any matter, this form of proxy will be voted FOR each of the matters of business above.

The Shares represented by this form of proxy will be voted for or against or withheld from voting, in accordance with the instructions of the holder, on any ballot that may be called for and, if the holder has specified a choice with respect to any matter to be acted on, the securities will be voted accordingly.
